 - 1.1. *Cover Letter:* The cover letter shall introduce the proposed firm, naming the key players and highlighting the firm's qualifications for the Project, and other relevant information as desired.
 - 1.2. *Company History* (please include for all team member firms, if the team consists of more than one firm) including:
 - 1.2.1. Provide a brief history of the background of your firm (including number of years in business and any former names under which the firm has operated).
 - 1.2.2. What is the single most important quality that your firm brings to the District?
 - 1.2.3. Annual revenues for the last five years.
 - 1.3. Proposed Team and Approach to Projects.
 - 1.3.1. Describe your firm's technical approach to evaluating and making recommendations to the District;
 - 1.3.2. Describe how your firm's qualifications set it apart from other prospective firms;
